1. CALL TO ORDER - ROLL CALL

The meeting was called to order by the Chairman, Chief Probation Officer Alan Crogan at 1:36 p.m.

2. APPROVAL OF MINUTES

Alan Crogan entertained a motion to approve the October 18, 2012 minutes of the Community Corrections Partnership Executive Committee (CCPEC) meeting (handout). Motion was moved by Alan Crogan, and seconded by Dave Brown. Alan Crogan requested a roll call vote of the motion which passed as follows:

Absent: Carter, Wengerd, Zellerbach

3. 2nd ANNUAL REALIGNMENT CONFERENCE

Assistant Chief Probation Officer Mark Hake provided feedback from the 2nd Annual Realignment Conference held in Sacramento. He briefly touched on day one and two stating that the conference started off with a presentation from Managing Associate Meghan Guevara from Crime and Justice Institute (CRJ) who set the tone of the conference by asking, "How can counties effectively manage the public safety risk posed by the criminals in their communities?" He also stated that Joan Petersilia, Ph.D. presented, "Looking Past the Hype: 10 Questions Everyone Should Ask About California's Realignment". Mark Hake then recommended that the CCPEC establish a work group to identify the performance objectives, and identify how the outcomes will be measured in Riverside County. He recommended to the committee that this initiative move forward. Chief Deputy Sheriff Raymond Gregory also commented about the conference and added that he and four others from the Sheriff's Department were in attendance and concurred with the suggestion. Assistant District Attorney Creg Datig shared his concerns and wanted to raise caution when setting measures. Stan

Sniff also commented and agreed with the work group suggestion. He added that the objectives and measures needed to be standardized and the committee would have to be selective on what to adopt.

Assistant District Attorney Jeff Van Wagenen also shared that while at the conference, he learned that the Court plays a more active role in their collaborative efforts in other counties. He recommended that the committee make more of an effort to bring the Court back as a valuable partner in the next calendar year and suggested asking the new Presiding Judge in January to attend as well as Sherri Carter.

Alan Crogan asked that each department contact Executive Secretary Andria Bartkowski with the name of each representative for the new work group. Mark Hake will be the lead for the Probation Department and will coordinate the first work group meeting.

4. REALIGNMENT STUDY PARTICIPATION

Mark Hake referred to the handout, "How Justice Systems Realign: CA's Realignment Law" that was provided by Stanford Law School with regard to this study. The Probation Department will coordinate with the facilitators in December to schedule interviews for completion of the study.

5. TYPE IV LOCAL DETENTION FACILITY

Ernie Wright requested a continuance on this agenda item to the December 4th CCPEC meeting.

6. PROPOSED CCPEC MEETING DATES FOR 2013

Alan Crogan motioned to approve the *Proposed CCPEC Meeting Dates for 2013* (handout). Motion was seconded by Dave Brown. Alan Crogan requested a roll call vote of the motion which passed as follows:

Paul Zellerbach joined the meeting at 1:58 p.m.

7. PUBLIC DEFENDER'S BUDGET PRESENTATION

Brian Boles presented the Public Defender's budget presentation and distributed the Year-End Budget Report ending on June 30, 2012. He indicated that the Public Defender's office has collected data from July 1, 2012 to current day, as followed: 175 appearances have been made on violations of supervised release; during that same time period, 457 appearances were made on PRCS cases. A total of 632 appearances on these types of cases which is indicated as an increase from last year. Prior to AB 109, these appearances on cases would not have been made. The Public Defender is in agreement for a 9-month budget request of \$684,556. Stan Sniff asked Paul Zellerbach what his experience was with Gary Windom last year with the amount that is currently being requested. Paul Zellerbach felt that action can be taken now.

Paul Zellerbach motioned to approve a 6-month budget of \$456,371 for the Public Defender's office. Motion was seconded by Stan Sniff.

Alan Crogan stated that it is the District Attorney and Public Defender's responsibility to go to the state to request the additional funding versus taking the money that was aimed for re-entry programs, program services, custody beds, health and substance abuse beds.

After further discussion, Paul Zellerbach motioned to amend his original motion to include that half of the Public Defender's award of \$456,371 will come from the Sheriff's Department and half from the contingency fund.

Chief Deputy Probation Administrator Rosario Rull requested further clarification from Brian Boles on whether he needed additional positions. He stated that he would not need additional positions at this time. Rosario Rull stated that the 9-month total cost from all positions is \$813,627 and the budget approved for 9-months is \$879,826, which is more than enough since he is not asking for more positions. Stan Sniff stated that they are not locked into making a decision at this time. Alan Crogan requested to bring this back as an action item at the request of the Public Defender on a later date. The previous motion was withdrawn for further consideration.

8. POLICE CHIEF'S BUDGET PRESENTATION

Alan Crogan stated that Dave Brown asked for this agenda item to be changed to a discussion item rather than an action item. Dave Brown stated that the Association of Police Chief's will not ask for additional money that they will not use. At this point, they have enough staff to get them through until the end of the year. The intent and proposal to increase the size of the team is still an initiative. The Police agencies are not asking for additional contingency funds. He did want to make clear that this committee made it optional later in the fiscal year to bring this issue back if funds were needed.

9. STAFF REPORTS

a) PROBATION: Chief Deputy Probation Officer Andrea Greer reviewed and discussed the AB 109 Status Report dated November 7, 2012 as follows:

- PRCS Packets Received from CDCR: 3,515
- Supervised Release Cases ordered by the Court: 1,532
- Total PRCS and Supervised Release Assigned to a Caseload: 2,888
- PRCS Warrants issued since October 1, 2011: 774
- PRCS Revocation Petitions filed since October 1, 2011: 1,089
- Flash Incarcerations since October 1, 2011: 377

Andrea Greer also reviewed and discussed PRCS Fact Sheet and the PRCS Population Packet (handout) dated November 7, 2012. Andrea Greer stated that they will add the statistics on supervised released, as requested by Paul Zellerbach. She also indicated that "Supervised Release" will be changed to "Mandatory Supervision" by the Court and will be reflected in the reports. Stan Sniff asked if this could be added as a footnote to the bottom of the reports regarding the change.

Effective October 15, 2012, the Day Reporting Center (DRC) was opened for the staff to move in. On October 22, 2012, the offenders started attending the DRC. To date, 107 referrals to the DRC and 27 offenders have received services. Lori Wilson gave additional updates on the DRC and plans on having an open house at the beginning of the year. Alan Crogan advised the members to contact Mark Hake if anyone was interested in touring the DRC.

b) SHERIFF: Chief Deputy Sheriff Raymond Gregory reviewed and discussed the AB 109 Impact Update (handout) dated November 1, 2012 as follows:

- Parole Violations (3056 PC) Total booked to date: 5,356
- Flash Incarcerations (3454 PC) Total booked to date: 451
- Post Release Community Supervision (PRCS) Violations (3455 PC) Total booked to date: 883

- Inmates Sentenced under 1170(h) PC for Felony Sentence to be served in County Jail. Total number of inmates sentenced per 1170(h) PC: 1,825
- Total number of inmates to date booked directly or sentenced to jail due to realignment: 6,654

Raymond Gregory mentioned that the Sheriff's Department is in the process of finalizing the Sheriff's Labor Program merger with their Work Release Program that will go online in a couple of weeks. He stated that this will be helpful for the AB 109 populations who have the ankle bracelets.

c) MENTAL HEALTH: Nothing to report.

d) POLICE: Dave Brown gave a brief update on the Post-Release Accountability and Corrections Team (PACT) as follows:

- 51 compliance checks (only 8 had bad addresses)
- 23 arrest (10 of those were PRCS arrests)
- 2 firearms were confiscated

PACT participated in three events in Hemet, Cathedral City and Palm Springs and assisted with any PRCS related offenses and absconders.

e) DISTRICT ATTORNEY: Paul Zellerbach apologized for being late to this meeting. He reported that the Court has hired a Court Hearing Officer as a part time position. He also added that he felt that it is important for the Court to continue to attend the CCPEC. Creg Datig discussed Fed Kicks and how the District Attorney is working with the Sheriff's Department in receiving the daily fed kick list which they have created a database.

f) PUBLIC DEFENDER: No further comments.

g) COURT: Nothing to report from the Court. Alan Crogan stated that he will be in contact with Presiding Judge Sherrill Ellsworth.

DISCUSSION

Alan Crogan mentioned that the budgets were approved for the Probation Department, Sheriff's Department and Mental Health at the board meeting on November 8th.

The December AB 109 Workshop will be rescheduled to a later date in January.

1. CALL TO ORDER - ROLL CALL

The meeting was called to order by the Chairman, Chief Probation Officer Alan Crogan at 1:32 p.m.

A quorum was not present.

2. APPROVAL OF MINUTES

Alan Crogan explained that the minutes for the November 13, 2012 Community Corrections Partnership Executive Committee (CCPEC) meeting could not be approved due to the quorum not being present. The approval of minutes will be held at the next CCPEC meeting on January 8, 2013.

3. TYPE IV LOCAL DETENTION FACILITY

Alan Crogan introduced Ernest Wright, Certified Corrections Executive from the Desert Pass Education and Training Center. Ernest Wright also introduced his business partner Tony Strout. He briefly discussed the Type IV Local Detention Facility letter that was distributed to the committee and asked the agencies to consider the Type IV Local Detention Facility as an option.

Assistant Chief Probation Officer Mark Hake added that he and staff attended a tour of the Correctional Alternatives Facility in San Diego. He stated that the San Diego Probation Department has worked with this facility for many years. He discussed how this facility is an offender paid program and briefly discussed the Work Furlough Program that this facility offers. Mark Hake offered to set up a tour of this facility for anyone interested in seeing the daily operations and the many options that the facility provides.

4. BOARD OF SUPERVISORS AB 109 WORKSHOP RESCHEDULED ON: JANUARY 15, 2013

Alan Crogan informed the committee that the AB 109 Workshop was rescheduled on January 15, 2013 at 2:00 p.m.

5. PROPOSITION 30 SUMMARY

Alan Crogan briefly discussed two items from the *CPOC Memo, Proposition 30 Summary* (handout) and added that he included this summary as information for the committee.

6. CSAC REALIGNMENT COURSE (REALIGNMENT 301: WHERE THE FUNDS FLOW)

Alan Crogan encouraged the committee to send a representative from their agencies to the CSAC Realignment Course being held on December 13, 2012. The Probation Department plan to send two staff.

7. PRETRIAL ASSISTANCE TO CALIFORNIA COUNTIES (PACC): WILLIAM WOODWARD

Chief Deputy Probation Officer Bryce Hulstrom explained that Riverside County was selected as one of only two counties in California to receive the PACC. He then introduced Mr. Woodward, the representative from the Crime and Justice Institute, who will be providing guidance and oversight in Pretrial Services for both counties.

8. STAFF REPORTS:

a) PROBATION: Chief Deputy Probation Officer Andrea Greer reviewed and discussed the *AB 109 Status Report* dated December 4, 2012. She pointed out that the *Supervised Release* category has been changed to *Mandatory Supervision* as indicated at the bottom of the page of the Status Report. She reviewed the status report as follows:

- PRCS Clients Assigned to a Caseload: 1,780
- Mandatory Supervision Clients Assigned to a Caseload: 733
- Total PRCS and Mandatory Supervision Assigned to a Caseload: 2,513

The Day Reporting Center (DRC) has received 141 referrals for services, 26 are currently receiving services and 17 have refused services which are being documented. The DRC has completed 60 intakes and have 60 more scheduled.

The Transitional Housing RFP closed on November 14th and had 5 bidders. An Evaluation Kick-off meeting was held on November 20th and an Evaluation Wrap-up meeting will be held on January 10th.

b) SHERIFF: Chief Deputy Raymond Gregory discussed and reviewed the *AB 109 Impact Update* (handout) as follows:

- Parole Violations (3056 PC) - Total booked to date: 5,592
- Flash Incarcerations (3454 PC) - Total booked to date: 479
- PRCS Violations (3455 PC) - Total booked to date: 987
- Inmates Sentenced under 1170(h) PC for Felony Sentence to be served in County Jail - Total number of inmates sentenced per 1170(h) PC: 1,932
- Summary – Total number of inmates to date booked directly or sentenced to jail due to realignment: 7, 054

Ray Gregory reported that the Sheriff's Work Release Program and the Sheriff's Labor Program have now merged. He also reported that the Electronic Monitoring Program is underway and currently has 80 qualifying in this program.

Ray Gregory stated that they are waiting on the final draft contract for Fire Camps from CDCR, and will then schedule the item to present to the Board of Supervisors for approval. He added that they are looking at 280 beds.

- c) MENTAL HEALTH: Jerry Wengerd distributed and briefly reviewed the *AB 109 Activity Report* dated from October 1, 2011 through November 16, 2012.
- d) POLICE: Commander Dan Bressler from Desert Hot Springs reviewed statistics on behalf of Dave Brown regarding the arrests and searches by the Post-release Accountability and Corrections Team (PACT) from May-October and November. Alan Crogan asked for this statistical report to be provided at the next CCPEC meeting in January.
- e) DISTRICT ATTORNEY: Assistant District Attorney Creg Datig reported that the District Attorney's office has assigned an experienced grade 4 level lead attorney to handle the PRCS hearings and appearances before the PRCS Hearing Officer to ensure continuity in the high level of service. Creg Datig was also interested in hearing from the Sheriff on the impact of Proposition 36 and the number of jail beds that they will have available. Creg Datig suggested that the Sheriff or a designee attend the meeting being held on December 5th with the Court to discuss Proposition 36 implementation.
- f) PUBLIC DEFENDER: Brian Boles further discussed the meeting with the Court regarding Proposition 36. Alan Crogan advised that Probation would like to send staff to this meeting as well. Creg Datig will inform the Court that Probation will also attend the meeting held in Department 41 at 12:15 p.m.
- g) COURT: Not in attendance.

OPENING REMARKS

Mark Hake informed the committee that Governor Brown held a press conference to discuss the state court filings in the latest Three Judge Panel hearings. Copies of the court documents will be available for review on request.

The Community Corrections Partnership Executive Committee (CCPEC) minutes for November 13, 2012 and December 4, 2012 will not be approved at this meeting due to a quorum not being present. 3. BOARD OF SUPERVISORS AB 109 WORKSHOP: JANUARY 15th, 2:00 P.M., CAC

Mark Hake advised that the Board of Supervisors AB 109 Workshop will be held on January 15, 2013. California Department of Corrections and Rehabilitation (CDCR) Undersecretary Terri McDonald will provide an overview of realignment from the state's perspective and will be available to answer any questions that the Board of Supervisors' may have. The department presentations will proceed in the following order:

- Police

4. PROP 36 IMPACTS

Assistant District Attorney Creg Datig indicated that the District Attorney's office is currently working with the Court and Justice Partners to develop and establish a procedure for re-sentencing cases. He explained how the process will work and how the judges may be assigned to these cases. Further updates and discussion will be presented to the committee.

Paul Zellerbach joined the meeting at 1:51 p.m.

5. AB 109 FY 2012/13 FINANCIAL REPORT SCHEDULE AND TEMPLATE

Mark Hake reviewed and discussed the *AB 109 CCPEC FY 2012/13 Financial Report – Operating Funds and Proposed Schedule* (handouts). This agenda item could not be approved with the lack of a quorum. Chief Deputy Probation Administrator Rosario Rull asked if the Chairman can refer to Deputy County Counsel David Huff on how to proceed in moving forward with using the revised Financial Reports. David Huff stated the action item will need to be held over to the CCPEC meeting on February 5, 2013. Each department may voluntarily submit their financial information prior to that date.

Grand Total PRCS and Mandatory Supervision Assigned to a Caseload: 2,564

Andrea Greer advised that the Day Reporting Center (DRC) has been operational for over two months. The Probation Department is currently working on a plan for the new DRC's permanent location. DRC updates as followed:

- Receiving Services: 79
- Referrals Received: 172
- Refused Services: 49
- Not accepted: 2

The Request for Proposal (RFP) for the Substance Abuse Sober Living Environments has been completed, which will encompass the Re-entry Housing. The RFP for the AB 109 Transitional Housing Program is continuing to make progress.

b) SHERIFF: Chief Deputy Sheriff Raymond Gregory reviewed and discussed the *AB 109 Impact Update* (handout) dated January 1, 2013.

- Parole Violations (3056 PC) - Total booked to date: 5,912
- Flash Incarcerations (3454 PC) - Total booked to date: 534

Initial Meeting Overview / CCPEC Brief

Working group met to discuss the development of measurable goals as per the instruction of the CCPEC. The following items were discussed:

- Defining the purpose and goals of the working group.
- Defining common and consistent language.
- Identification of potential measurable data as it pertains to each agency and determining what measurable goals were of specific interest to each agency.
- Identification of common goals and priorities among all groups.
- Development of a draft reporting system for CCPEC review.

The following is a brief overview and status of the above discussion items;

Defining Purpose and Goals of the Working Group

A brief discussion was had to ensure all group representatives were on the same page reference the Executive Committee's direction. The group was to be chaired by the Probation Department with representatives from each of the participating committee's members. The purpose of the group is to develop a defined set of measurable goals that will allow the CCPEC to gauge effectiveness of our response to Realignment. These draft measurable goals would be presented to the CCPEC for their review and input. The defined and approved measurable goals would then be tracked and reported monthly to the CCPEC.

Defining Common Language

The working group discussed the need to establish common language and terminology to allow for consistent tracking and reporting of data. As the working group begins to develop the focused data sets we will define common definitions and language to allow for consistency and accuracy of data collection.

Identification of Individual Agency Data Set Focus

Each agency presented their focused areas of concern regarding measurable data collection relative to Realignment impact. Once each agency provided their data, areas of common goals and cross-over data was developed.

Common Goals and Priorities Identified

The following is the initial list of Common Goals and Priorities regarding measuring data relative to Realignment Impact.

- The most common prevalent goal and priority is the sharing and access to data. The development of a shared data system or having a data system that can link to each of our existing systems to allow query and analysis of focused data sets was determined to be essential to the effectiveness and efficiency of our future reporting format.
- Tracking of the volume of In-custody impact
 - Impact upon Housing
 - Fed Kicks (Volume and Analysis)
 - Fed Kicks - Recidivism
 - Alternatives to Sentencing
 - Success and Failure rate
 - Programs and Services Provided
 - Continuity and communication of services with Out of Custody programs
 - Total Impact on the entire Criminal Justice System
- Tracking of Out of Custody Programs
 - Effective Supervision
 - Volume of case management / Impact
 - Success and Failure rate
 - Support Efforts - PACT
 - Programs and Services Provided
 - Continuity and communication of services with In Custody programs
 - Success and Failure rate
 - Assessment and Reporting of offenders
 - Both in custody and out of custody
 - For Alternative Custody
 - For Court Assessment
 - To Combat Recidivism

RE: AB 109 Impact Update

Since State Prison Realignment under AB 109 went into effect, the jails in Riverside County have experienced a substantial increase in inmate population. As of this morning, our jail population stood at 3,688 inmates, or 96% percent of our maximum capacity (3,842 beds). In the first week of January 2012, our facilities hit maximum capacity, requiring us to initiate releases pursuant to a Federal Court Order to relieve overcrowding. Last year, 6,990 inmates were released per the court order. 779 inmates have been released year-to-date in 2013 per the court order. In the past year (since January 31, 2012), these Federal Court Order releases have caused 7,565 inmates to be returned early to the community.

Inmate bookings since AB 109 went into effect which are directly related to realignment are:

Parole Violations (3056 PC)

Total booked to date is 6,229 (4,113 booked for violation only; 2,116 had additional charges)

The number of inmates currently in custody serving a parole violation only is 174.

Flash Incarcerations (3454 PC)

Total booked to date is 596. The number of these inmates currently in custody is 19.

Post Release Community Supervision (PRCS) Violations (3455 PC)

Total booked to date is 1,261 (658 booked for a violation only; 603 had additional charges).

The number of inmates currently in custody serving a PRCS violation is 107.

Inmates Sentenced under 1170(h) PC for Felony Sentence to be served in County Jail

The total number of inmates sentenced per 1170(h) PC is 2,326.

The number of these inmates that remain in custody is 553, or about 15.0% of the total jail population.

216 of these inmates have been sentenced to 3 years or more, with the longest local sentence standing at 12 years, 8 months.

Summary

The total number of inmates to date booked directly or sentenced to jail due to realignment is 8,295.

The number of those currently in custody is 853, or approximately 23.1% the total jail population.
