MINUTES

1. CALL TO ORDER – ROLL CALL

The meeting was called to order by the Chairman, Chief Probation Officer Alan Crogan at 1:38 p.m.

2. APPROVAL OF MINUTES

Alan Crogan entertained a motion to approve the December 20, 2011 minutes of the Community Corrections Partnership Executive Committee (CCPEC) meeting. Motion was moved by Patrick Williams, and seconded by Sherri Carter. Alan Crogan requested a roll call vote of the motion which passed as follows:

- Aye: Crogan, Zellerbach, Carter, Williams.
- Nay: None.
- Absent: None.

3. FISCAL REPORTING PROCEDURES – ACTION ITEM

Alan Crogan referred to the AB 109 Positions Report that was included in the meeting packet. The preliminary report includes the current numbers of the authorized positions that are vacant and currently filled from each CCPEC County agency.

Paul Zellerbach questioned the accuracy of the District Attorney’s Schedule A Positions Summary Report and needed to get clarification from his office regarding the data that was submitted to Probation Administrative Services Manager Doug Moreno. Assistant Chief Probation Officer Mark Hake advised that Doug Moreno will revise the report with any corrections from the District Attorney’s office prior to presenting to the Executive Office.

Alan Crogan entertained a motion to accept the Fiscal Procedures Work Group Report and recommendations for Schedule A of the FY 2011/12 Community Corrections Partnership Executive Committee Fiscal Reporting. Motion was moved by Patrick Williams, and seconded by Alan Crogan. Alan Crogan requested a roll call vote of the motion, which passed as follows:

Aye: Crogan, Zellerbach, Carter, William.

Nay: None.

Absent: None.

4. BUDGET REVIEW - DISCUSSION ITEM

Mark Hake reported on October 11, 2011, the committee approved the budget allocations and requested a budget review be set for 90 days. However, on December 20, 2011 the Fiscal Procedures Working Group made a recommendation to the committee, which included a schedule for fiscal reporting dates and the reporting deadline for the 1st quarter budget set for January 17, 2012. To accommodate the request this item will be continued and put on the February 7, 2012 agenda to allow the fiscal staff sufficient time to meet the January 17, 2012 deadline and prepare a report for the committee.

5. STAFF REPORTS – DISCUSSION ITEMS

Alan Crogan received a request from a member of the public asking that when the committee has any handouts to make a sufficient amount of copies for the committee members and public.

a) CHIEF OF POLICE:

Patrick Williams advised that they are targeting February 1, 2012 to start Task Force Operations but they still do not have a Memorandum of Understanding (MOU) to give out to the agencies. He stated that they do not have the reimbursement piece figured out and that it is an issue for the agencies. He also stated that the agencies are a contract service to Probation and need a mechanism for the money to flow from Probation to the agencies. Desert Hot Springs agreed to be the fiscal agent for the participating agencies. Mark Hake advised that the MOU is a priority. He cannot give an estimated date of completion until he speaks to probation's contract person.

Patrick Williams distributed and reviewed two memorandum handouts from the office of the Attorney General and the Probation Department in regards to the release of information from the Probation Department to law enforcement agencies and local law enforcement not having access to Probation's AB 109 client information. He asked for the committee to review before the next meeting and have it agendized.

b) COURT: Nothing new or additional to report since the last meeting.

c) DISTRICT ATTORNEY: Nothing new or additional to report since the last meeting.

d) MENTAL HEALTH: Assistant Director for Mental Health Donna Dahl reported on behalf of Jerry Wengerd that the Health and Social Service's Committee have been meeting to discuss services and the delivery of services regarding the AB 109 population. The committee is working on developing training specifically on what services are available and how to access that information. The committee is in discussion regarding the One Stop Shop and bringing together Mental Health, Public Health, benefits staff and community resource information so that it can be brought to the AB 109 population all at one time. She advised that there is concern about providing services for AB 109 inmates and long term services. There is a special group working that was put together to help find Transitional Housing and Emergency Housing for this

population. She further advised they are working on how to track the AB 109 population, cost, and what specific services are needed.

Paul Zellerbach asked if there were any distinction between the AB 109 inmate and a non-AB 109 inmate. Chief Deputy Jerry Gutierrez informed that they have already made this distinction. In regards to the severely acute mentally ill, they have one housing unit already and have plans for a second housing unit in their Banning facility. Assistant Sheriff Steve Thetford clarified that they have established a baseline in tracking the AB 109 inmates for the cost.

e) PROBATION: Division Director Bill Palmer reported the following statistics as of January 6, 2012; the handout will be distributed to the CCPEC via email following the meeting and made available to the public on the Probation Department's website.

- Total packets received from CDCR: 1,584
- Number of intakes completed: 1,045
- Number assigned to supervision: 661

Bill Palmer distributed and reviewed a handout regarding the PRCS Population by City.

f) PUBLIC DEFENDER: Assistant Public Defender Christina Voss, reported on behalf of Gary Windom, nothing new or additional to report since the last meeting.

g) SHERIFF: Jerry Gutierrez distributed and reviewed a handout regarding the AB 109 impact update as of January 9, 2012; the average daily population has increased to 97% and at their maximum capacity. The following statistics were reported:

- CDCR Commits – 101 inmates
- Riverside Sheriff's Department Commits – 1,038 inmates
- Flash Incarceration – 20
- PRCS Violation – 40
- Total Sentenced Commits - 2,161 inmates
AB 109 impact – 505 inmates (23.4% of all commitments)

6. FINAL IMPLEMENTATION PLAN STATUS – DISCUSSION ITEM

Alan Crogan advised the Probation Department has received all of the Implementation Plans except for one. Bill Palmer will compile the information and present it all in the same format. The goal is to have the project completed by January 24, 2012 for review by the committee members. Committee members will have three days to review it and give feedback. The Final Implementation Plan will then be sent out to the committee on January 27, 2012, and then vote on February 7, 2012 in order to take this before the Board of Supervisors on February 28, 2012.

Sherri Carter questioned whether the Implementation Plan may be updated in a year and Alan Crogan explained by law there is no requirement for updates or revisions. However, it can be amended if needed.

7. PUBLIC COMMENTS (NON AGENDA ITEMS)

Petra Fuhriman, gave an overview of the services offered by GPS Monitoring Solutions, Inc., located in the Riverside and San Bernardino area. They would like to be a resource for the Probation Department and provide services that will not incur cost to the county.

Steven Figueroa President of the Inland Empire Latino Coalition and advisory board member for Disability Rights and Legal Center expressed concerns about how the AB 109 realignment will impact our neighborhoods and youth. He suggested to the Sheriff and to Mental Health that they have a transitional plan of action before the AB 109 inmates are released. He would like to work together as a community.

8. NEXT MEETING

Sherri Carter moved that the CCPEC meeting date of February 7, 2012 be canceled. Alan Crogan advised that this will be added to the January 24, 2012 CCPEC meeting agenda as an action item.

The next CCPEC meeting will be held on January 24, 2012, 1:30 p.m., Downtown Law Building, 5th Floor.

Alan Crogan entertained a motion to adjourn; motion was made by Sherri Carter, and seconded by Pat Williams. The meeting was adjourned at 2:39 p.m.
