CALL TO ORDER – ROLL CALL

The meeting was called to order by Chief Probation Officer Alan Crogan at 2:10 p.m.

APPROVAL OF MINUTES

Alan Crogan entertained a motion to approve the September 26, 2011 minutes of the Community Corrections Partnership Executive Committee (CCPEC) meeting. Motion was moved by Public Defender Gary Windom, seconded by Executive Officer Sherri Carter. Oppositions/Abstentions: None. Minutes were approved and stand as written.

ADOPT BUDGET – ACTION ITEM

On behalf of the CCPEC Budget Working Group, Assistant Chief Probation Officer Mark Hake presented FY 2011/12 Community Corrections Partnership Executive Committee Budget Recommendations (included in meeting packet). After discussion, Alan Crogan made a motion to approve the following recommendations of the Budget Working Group; the motion was seconded by Gary Windom:

- 1) Receive the staff report FY 2011/12 Community Corrections Partnership Executive Committee Budget Recommendations.
- 2) Adopt the proposed distribution of the Post-release Community Supervision (PCS)/local incarceration allocation for FY 2011/12.
- 3) Adopt the proposed distribution of the AB109 Training and implementation activities allocation for FY 2011/12.
- 4) Set this matter for review by the CCPEC on January 10, 2012.
- 5) At the conclusion of FY 2011/12, return unused funds from this and subsequent distribution decisions of the CCPEC for re-distribution in FY 2012/13.

Alan Crogan requested a roll call vote of the motion which did not pass as follows:

Aye: Windom, Wengerd, Crogan.

Nay: Sniff, Zellerbach, Williams, Carter.

Motion was amended by Gary Windom; seconded by District Attorney Paul Zellerbach to approve items numbers 1-4 only (listed above); and to continue item number 5 (listed above) for further discussion at the next CCPEC meeting on October 25, 2011. Alan Crogan requested a roll call vote of the amended motion which passed as follows:

Aye: Zellerbach, Sniff, Carter, Crogan, Windom.
Nay: Williams, Wengerd.

Each department that received authorization for funding from the CCPEC will proceed with a Form 11 for final approval from the Board of Supervisors.

STAFF REPORTS- DISCUSSION ITEMS

- SHERIFF'S DEPARTMENT: Chief Deputy Sheriff Jerry Gutierrez provided an update on sentencing that the Sheriff's Department has experienced during the first ten days of AB109. He advised to date there have been approximately 163 offenders (non-non-nons) sentenced; 138 of those were sentenced to County jail. Additionally, 37 offenders were sentenced to more than three years.
- PROBATION DEPARTMENT: Division Director Bill Palmer reviewed a PCS Offender Summary (included in meeting packet). He advised that as of October 6, 2011, there have been approximately 490 packets received and 23 offenders have reported countywide. Bill Palmer indicated that PCS data will be entered into the Supervised Release File (CLETS) system and a procedure is in the works for law enforcement to contact a central location at a juvenile institution after hours.

PUBLIC COMMENTS (NON AGENDA ITEMS)

There were no public comments regarding non-agenda items.
